We see issues that we thought had been "settled" now have become front-page news, such as access to health care for people at all income levels, forthcoming challenges to Roe v. Wade, and freedom to make personal reproductive choices. "Rights" that women have taken for granted are now at risk!

Approximately \$6500 was sent to our AAUW national office as our branch's contribution to AAUW funds for 2016. Profits from our 50<sup>th</sup> Anniversary event were submitted for Tech Trek scholarships. Several members wrote personal checks also for Tech Trek donations, while at this event.

Additionally AAUW funds were at the fall breakfast for TT and LAF. The sale of poinsettia plants was strong due to several large orders. The sale of Named Gift Honoree pins was good with 14 branches ordering pins. The sales of our <u>Profiles of Women</u> books were minimal with 5 CD's sold and 3 books. The Women of Conejo notecards were good at public events. The stock of cards is low with less than 200 sets left.

#### Dreamers and Allies Group at Thousand Oaks High School Expands

The Thousand Oaks AAUW-sponsored Dreamers and Allies group at Thousand Oaks High School, begun in the fall, has continued to have a vital role in meeting with Immigrant students in the face of their concerns over potential changes in United States laws and policies as a result of our November elections.

## Congresswoman Brownley Meets with Dreamers/Allies

Congresswoman Julia Brownley, a member of our Branch, recently held a Dreamers Town Hall at Pacifica High School in Oxnard. We heard from three Dreamers who shared their stories of great academic success, as well as their struggles and fears. The most important support for these young folks is community building with those who are in a similar position and with those that support them. We also heard from two prominent immigration attorneys. Congresswoman Brownley was clear that she is dedicated to fight for the support and protection of immigrants and dreamers. She spoke to protecting DACA, Deferred Action for Childhood Arrivals. and to the rights of those who do not yet have documentation. She spoke about the California Dream Act and financial aid for undocumented students. Congresswoman Brownley was firm, "I'm ready and my colleagues are ready to fight for dreamers all the way." She encouraged all of us to reach out to our elected officials to let them know of our concerns.

# Message Sent to All Branches By Lisa M. Maatz, AAUW Vice President, Government Relations

In January, the Senate began its consideration of the new president's nominations for cabinet level positions. AAUW believes that any nominee must be a fair-minded individual committed to equal opportunity and justice under the law for all Americans. A full vetting of each Cabinet nominee must include close examination of the candidate's record, and meaningful answers to threshold questions concerning qualifications, temperament, and enforcement of current law. Most critically, senators should not move forward any nominee whose background check and ethics screening remains incomplete.

AAUW has grave and deep concerns regarding the nomination of four individuals: Betsy DeVos for Secretary of Education, Sen. Jeff Sessions for Attorney General, Andrew Puzder for Secretary of Labor, and Rep. Tom Price for Secretary of Health and Human Services. These individuals stand to have significant influence over issues affecting women and families, but their records on AAUW's public policy priorities leave much unanswered and much to be desired.

Why do presidential cabinet picks matter to women and girls? From campus sexual assault to sex discrimination in employment to reproductive health care, all kinds of <u>critical issues</u> are at stake in a new administration.

The president's personnel decisions are really policy decisions, and they matter to women and girls. AAUW members will be watching these confirmation hearings with our mission in mind. <u>Make sure Senators Dianne Feinstein and Senator Kamela Harris know that</u> AAUW has strong concerns about these nominees. (At time of this writing, the info was correct).



#### Ever Hear of the Mayme Clayton Library and Archives? Join us on the Museums and Gardens Trip

We will carpool to the Mayme Clayton Museum and Archives in Culver City for a private tour given by Lloyd Clayton, the son of the founder. This absolutely astonishing collection contains over two million rare books, films, documents, photographs, artifacts, and works of art related to the history and culture of African Americans in the US. The collection is one of the most important collections chronicling the history and culture of Americans of African descent. This trip will provide a rare opportunity for us to also see "the best of the best" in this collection, as Lloyd opens up special collections for us. *Today this is the largest privately held and the most academically substantial archive of African American history and culture in the world.* 

Dr. Mayme Clayton, a librarian for both USC and UCLA, started her collection about 50 years ago, which she housed initially in her garage. Over time, she single-handedly collected rare books (e.g., Phyllis Wheatley first edition); manuscripts and archival documents (e.g., letters of Booker T. Washington); film and recorded sound items (e.g. early jazz recordings); photographs and prints collection (e.g., Gordon Parks photography); and art and artifacts (e.g., Civil War era dolls). Today the collection is housed in a former historic LA county courthouse, which has been modernized and refurbished. (For more information, see http://www.claytonmuseum.org/)

This will be a wonderful opportunity to see a very rare collection, which was nearly single-handedly created by an amazing woman. Tour arrangements have been made for us for *Thursday*, *Feb. 9.* We will be meeting to arrange our carpools from the Barnes and Noble in *Westlake at 10 AM*. I'm expecting that we should return sometime before 3:30 pm. The cost will be your share of gas (cash only), a library tour fee (\$10 cash), and your own lunch costs. 
