Over the past three months, I have tried to provide a few observations about, what I call the Four Pillars of AAUW: Advocacy, Education, Philanthropy, and now we come to the final pillar, "Research". The purpose of this background is aimed at primarily our newer members, of which we have many! However, it can always be beneficial to all members to be reminded of the foundations of our organization.

As our national website states, "AAUW conducts groundbreaking research on issues related to gender equity in education and the workplace. Our work influences the national discussion on topics like the pay gap between women and men, sexual harassment in schools and on college campuses, and the underrepresentation of women in science and engineering. Through new and traditional media, targeted outreach to policymakers, and member efforts, AAUW research serves as a catalyst for action".

Our Branch has used these research reports in a multitude of ways. Often it is for community outreach, like "Crossing the Line" was used at a parent night dealing with the topic of sexual harassment. The "Simple Truth to The Gender Pay Gap" was recently used at the successful Equal Pay Event at CLU. In addition, "Why So Few" is consistently used when we look at STEM Careers for girls. The use of the AAUW Research reports by other scholars in related fields, governmental agencies, the media and a wide range of other organizations is very high. I have often noticed that Dr. Catherine Hill, Director of Research, is a guest on PBS News Hour, especially when a new report is released.

We should all be very proud of the quality, validity, and reputation of AAUW Research....our Fourth Pillar

AAUW FUNDS EDUCATIONAL FUNDING AND AWARDS—2016-17

AAUW fellowships and grants have provided more than \$100 million for the 2016–17 academic year. The Thousand Oaks branch has three endowments: Thousand Oaks 30th Anniversary Endowment, and the Marilyn Carpenter and Ann Bratmon scholarships.



Christine Morrison is the recipient of an American Fellowship sponsored partially by the Thousand Oaks Branch 30th Anniversary fund. Christine is studying at the CA Institute of Technology and will be earning a PhD, Organic Chemistry. Her research relates to how bacteria are able to make their own fertilizer. Christine hopes to inspire alternative methods for producing human made fertilizers that are more sustainable and better for the environment.

This year's recipient of the Marilyn Carpenter endowment is **Je'Ne Chastain** who has received a Career Development Grant. As a leader in the field of architecture her focus has been on the intersection of design and business strategy. She is using her scholarship to complete a master's degree in business from Mills College Graduate school of Business and Social Policy.

Also receiving a Career Development Grant funded through the Ann Bratmon endowment is **Jacqueline-Joy Austria**. Jacqueline is pursuing a master's degree in instructional design and technology at Cal State Fullerton. She currently works in the technology field at a non-profit independent school. Upon graduation she hopes to work in educational technology to improve skills of students and faculty.

The Tournament of Roses Headquarters in Pasadena is situated in the stately 18,500 square foot Wrigley Mansion and is surrounded by a large incredible Rose Garden! This is the destination for the <u>Museum and Gardens</u> group trip on Thursday, May 25. We will have a guided tour of the impressive mansion and plenty of time to enjoy the very large gardens.

Chewing gum magnate William Wrigley Jr. purchased the home in 1914, after eight years of construction, for \$170,000. A year later, he paid \$25,000 for the adjoining property, clearing the way for what is now known as

the Wrigley Gardens. In its time, the Wrigley's winter residence was considered a more modest home on "Millionaire's Row." Of the Wrigley's six homes across the country, the Pasadena getaway was Ada Wrigley's favorite.

Surrounding Tournament House are the Wrigley Gardens, which feature a 4.5-acre floral display of more than 1,500 varieties of roses, camellias and annuals. The gardens feature the All-America Rose Selections award-winning Tournament of Roses roses.

We will car pool to Pasadena, leaving Barnes and Noble in Westlake about 10:30 AM, eating perhaps a picnic lunch at the very picturesque Arlington Park before making our way over to the mansion. Our return time is sometime prior to 5 PM, traffic permitting.

Detention Witness Article – Betty Stapleford

We hear a lot today about undocumented immigrants being arrested and deported. But little is reported about the existence of detention centers, nearly 250 of them, throughout our country. That is where those who are undocumented are usually held between the time they are detained by ICE (Immigration and Customs Enforcement) and

either deported or released (less likely). And their incarceration can range from months to years.

The closest center to the Conejo Valley is the Adelanto Facility. It is run by a for-profit company in the high desert near Victorville and houses over 1400 men and women. And because of its remote location, detainees are seldom able to see their loved ones. Nor do most of them have access to legal counsel because of their lack of funds or to activities other than menial labor for a salary of one dollar a day. It is to this facility that I go monthly with a group of others to visit detainees.
