## As explained on Page 1, our AAUW Branch is part of Ventura County IBC. We are also members of California AAUW. An important message from California AAUW follows:

As of January 22nd, 2018 the vote to change AAUW California back to a Public Benefit Corporation failed due to four "no" votes.

As explained in the pre-vote materials and on the ballot, just one "no" vote causes the measure to fail per California Corporate regulations governing Mutual Benefit Corporations (our current classification). Our pre-vote materials extensively explained the ramifications of a "no" vote and its long-term impact to the organization. We are now facing a lengthy and expensive legal process to reclassify AAUW CA to a Public Benefit Corporation The ballot measure members recently voted on was the most efficient and cost-effective process. AAUW CA must be reclassified, one way or another, in order to remain an affiliate of AAUW and to participate in all AAUW programs, to include Tech Trek.

Any member who cast a "no" vote has the opportunity to change that vote to a "yes" vote up until February 10, 2018, by contacting <a href="mailto:governance@aauw-ca.org">governance@aauw-ca.org</a> and requesting that their vote be changed. After that date, AAUW CA will move into a complex and costly appeal process with the State of California.

## Membership Dues Update

The AAUW Board of Directors voted in June 2017 to enact the first dues change in almost a decade. Effective March 16, 2018, national dues will increase from \$49 to \$59.

Annual dues currently account for 13 percent of AAUW's annual budget. They help to sustain and grow AAUW's programs and work that advances equity for women and girls. A combination of dues, donations, and corporate and foundation funding is critical to supporting AAUW's <u>salary negotiation workshops</u>, groundbreaking <u>research</u>, <u>advocacy</u> efforts, <u>campus</u> <u>leadership programs</u>, and so much more.

We believe we can do great things together and thank you for your continued support.

# AAUW FUNDS Submitted by Jeanette Hosek

A Look Back – Since 1981, LAF has provided millions of dollars to balance the scales of justice for people working toward gender equity through the legal system. For example there was the case of Janet Conney v. The Regents of the University of California et al.

Janet claimed that she began experiencing a hostile work environment in 2001, after male colleagues made inappropriate comments about her and other women, including comments about their bodies. She also learned that men working in positions similar to hers were making 50–100 percent more than she was. She complained about the harassment and pay inequity and her position was subsequently terminated in 2002. Conney filed a claim in 2003, and LAF began supporting the case in 2004.

After trial in 2004, she was awarded a total of \$2.95 million in damages. The university appealed, but in 2006, the California Supreme Court declined to contest the original verdict and awarded Conney an additional \$4.07 million.

As sexual harassment allegations and instances of the gender pay gap\_continue to come to light in media, it is plain to see that while we have come a long way in establishing and defending women' safety and equity in the workplace, we still have a long way to go before we achieve true equity. AAUW has a 37-year record of standing with plaintiffs who have made a difference for women and girls across the country, and with your help we will continue to support and amplify the voices of our plaintiffs in years to come. Our branch raised close to \$1000 for LAF through contributions and poinsettia sales. Thanks to our members.

The women's suffrage activists were great tea drinkers. They used tea parties and receptions to raise money for the cause and as occasions to get together and plan their activities and actions. By 1914, tea continued to foster the fight for women's rights when porcelain tableware including a teapot with 'votes for women' emblazoned on the front was used. The events raised money for the suffrage movement and guests at each event took home "votes for women" teacups and saucers. Tea was literally helping to get the word out! The tireless efforts of these strong women were rewarded in 1920 with the addition of the Nineteenth Amendment granting women the right to vote.

## PUBLIC POLICY SUBMITTED BY BETTY STAPLEFORD

For those of you who may have been concerned about our support of Dreamers in in our local schools through our Conejo Conexiones program, please note the following information from the AAUW National Office.

"The Federal District Court in San Francisco issued an injunction on Tuesday (January 16) that temporarily blocks the end of the Deferred Action for Childhood Arrivals (DACA) program. President Donald Trump ordered a stop to the Obama-era program in September, giving Congress until March to find a legislative solution. The judge's ruling requires the administration to begin accepting renewal applications again, but does not require they process new applications. While the injunction offers temporary relief for DACA recipients, a permanent legislative fix is still necessary. AAUW opposed the decision to end DACA and will continue to stand by Dreamers and defend their right to an education by advocating for timely action and passage of a clean Dream Act."

"Tell Congress we must protect Dreamers and pass the Dream Act today!

The Dream Act is a bipartisan, bicameral bill that would offer many, including DACA recipients, protection from deportation while allowing them to continue to access education or work and contribute to our society. Our higher education system and our economy are stronger because of the contributions of DACA recipients. . . . Send a message to your members of Congress that urges their support for a clean Dream Act."

### GLOBAL AWARENESS AND ACTION FOR GIRLS - e-interest group

**NICHOLAS KRISTOF**, the author of <u>Half The Sky</u> and writer for the New York Times on global issues recently wrote an article titled "Why 2017 Was the Best Year in History". He begins the article by stating that you might think 2017 was the worst year ever, "but you'd be wrong....as 2017 was probably the very best year in the long history of humanity". He cites the following reasons:

- A smaller share of the world's people were hungry, impoverished or illiterate than any time before
- A smaller percentage of children died than ever before
- A smaller proportion of people were disfigured by leprosy, blinded by trachoma or suffering from other ailments.

#### **Kristof** goes on to say that:

- The number of people living in extreme poverty has gone down.
- The number of people who have gained access to electricity and clean water increased.
- Fewer than 15% of the global population are illiterate.
- Since 1990 more than 100 million children have been saved by vaccinations, diarrhea treatments, breast-feeding promotion and other simple steps.

The data comes from a website called <u>Our World in Data</u> maintained by Oxford University economist, Max Roser. Kristof concludes that the world "is a dangerous mess", but the most important thing to recognize is that there has been genuine progress with major gains in health, education and human welfare for women and children.
