# PRESIDENT'S MESSAGE by Bonnie Shubb

As I turn the reins over to **Sharon Dyer**, this

Message. Generally, AAUW is rather idle during

the summer months. Except for planning our spectacular Fall Membership Breakfast, our budget, and an outline of our mission-based programs for the coming year, we are usually rather quiet. Unfortunately, we cannot be quiet this year. There are several issues in our State and in our local community which require our involvement if we are serious about our mission. When questioned at the California State Convention, AAUW CEO, Kimberly Churches responded: "We are nonpartisan, but we are **not** issues-neutral." That's why on Tuesday, June 5, I hope to be speaking in support of CA Senate Bill 54 at the Thousand Oaks City Council Meeting, where they are expected to vote whether or not to follow the State's law for Thousand Oaks to be a sanctuary city. AAUW CA's public policy promotes programs that address human rights and women's and girls' issues. This Senate Bill does just that. It curtails use of state and local resources from engaging in deportations and creates safe spaces, including schools, health facilities, and courthouses. The City Council meeting starts at 6pm and we hope to fill the seats with like-minded Thousand Oaks residents. Please

## **AAUW National Proposed Bylaws Revisions**

## Deadline to Vote for the following three AAUW National By-Law Amendments is June 9.

The AAUW National Board has proposed three bylaws amendments to be voted on by members. Members may vote electronically starting April 25, 2018 through June 9, 2018, or request paper ballots starting April 16, 2018. Too late for paper ballots, but just call 800-326-2289 for your member number and pin number and they will help you vote online.

The proposed bylaws will appear in the spring AAUW Outlook magazine and voter PINs will be emailed to members and mailed with the spring AAUW Outlook magazine to members without registered email addresses. Our AAUW Thousand Oaks board briefly discussed the three proposals at the April board meeting and decided to send a brief summary out to members

#### Proposal # 1 - Staggered terms of office for AAUW Board of Directors on a 3 year rotation.

A staggered term is a procedure whereby members of the national board will be elected at three year intervals, thereby allowing for a portion of the board to turn over rather than the entire board. This is considered a best practice for nonprofit boards. The individual terms of office will be increased from two years to three years. This proposed bylaw also allows for additional changes to the number and naming of officers and directors. See the website for more detail.

#### Proposal # 2 - Membership requirement for AAUW Board of Directors

Currently, only *individual* members of AAUW may serve as an officer or director of AAUW. This proposed bylaw would allow up to five non-members of AAUW to serve as directors, with a minimum of ten directors being individual AAUW members. The rationale for this proposed change is to open the AAUW board to people who may not be members of AAUW but could bring a wealth of experience to our organization. As an equity-seeking organization AAUW needs to welcome those who are not currently members of AAUW but can make a contribution to by their professional experiences, geographic location and other diverse views. #### Proposal #3 - Degree Requirement for membership in AAUW

Over the history of AAUW, membership requirements have changed. Founding members sought to remove barriers to getting an education by women, as it was uncommon for women to have degrees at that time. Today, non-degreed women work in every industry and field. So it is important for AAUW to recognize the power of welcoming anyone who supports our mission, as is common practice with mission-based non-profits. Eliminating the membership requirement will promote a more inclusive and diverse membership. Also, widening membership will enable AAUW to seek new funding from corporations. Adoption of this bylaw will eliminate all the eligibility requirements of the current bylaws and replace them with the following sentence: AN INDIVIDUAL WHO PAYS ANNUAL DUES TO AAUW AND SUPPORTS ITS MISSION SHALL BE ELIGIBLE TO BE AN INDIVIDUAL MEMBER WITH ALL RIGHTS AND RESPONSIBILITES OF AAUW MEMBERSHIP. The AAUW Thousand Oaks board has <u>not taken a position</u> on any of these recommendations. The board urges all members to read and vote on these proposed bylaws amendments. Voting will open on April 25 and close on June 9, 2018. Click <u>www.aauw.org</u> for voting information.

AAUW Members have received their on-line ballot concerning the three proposed amendments to the AAUW National bylaws. Voting ends on June 9, but don't delay in casting your vote.

OTHER LOCAL SCHOLARSHIPS: The branch supports local scholarships for graduating high school students from under-represented groups when funds are available.




